Procedure

- 1. In a vessel equipped with heating and agitation capabilities, charge Deionized Water.
- 2. Heat to 70 °C-75 °C (158 °F-167 °F) with mixing.
- 3. Add Phase 2 ingredients with continuous mixing. Mix until homogenous. Continue to mix for 30 minutes.
- 4. Cool batch slowly down to 40°C (104 °F) with mixing.
- 5. Add Fragrance.
- 6. Adjust pH to 3.5-4.0 with 50% Citric Acid Solution.
- 7. Add dye and preservative.
