Description	This body scrub uses finely-ground volcanic pumice to gently remove dead skin cells while naturally-derived oils provide moisture and softness. Unlike traditional body scrubs that can be difficult to rinse and leave skin feeling greasy, this water- and surfactant-based scrub rinses easily to leave skin soft and clean. All ingredients are compliant with the Whole Foods Market® Premium Body Care standard as of April 2018. (Note: Whole Foods Standard was reviewed by S. Kovach on April 15, 2018. Procedure	1. In a suitable vessel, charge pre-melted STEPAN-MILD® GCC and Shea Butter. 2. Charge Soybean Oil and mix together with a spatula. 3. Charge ALPHA-STEP® PC-48 and mix gently with a spatula until a thick lamellar phase is obtained. 4. Transfer Phase 1 to a half-ounce mixing bowl. 5. Charge Fragrance & Extract. 6. Charge Pumice Powder slowly in increments and mix with spatula until homogenous. 7. In a separate small container, charge the Deionized Water and Preservative and mix until homogenous. 8. Add Phase 3 to Phase 2 container and mix with spatula until homogenous.
