Procedure

- 1. Into a vessel suitable for mixing and heating, charge Phase 1 ingredients.
- 2. Mix and heat to 80-85°C (176-185°F) until homogenous and clear.
- 3. Measure the pH of the sample, by making a 10% solution in Deionized Water. Adjust the pH using Lactic Acid until pH of 3.5 to 4 is reached.
- 4. Add Fragrance and Dye and mix until homogenous.
- 5. Pour hot liquid into a silicone mold and alllow to cool until fully set.
