Procedure	<ol style="list-style-type: none"> 1. In a vessel equipped with heating and agitation capabilities, charge Phase 1 ingredients. 2. Heat to 50-60 °C (122-140 °F) with mixing. 3. In a separate vessel, premix Phase 2 ingredients until clear and homogenous. 4. Add Phase 2 to Phase 1 with continuous mixing. Mix for 15-20 minutes until clear and homogeneous. 5. Cool to 25 °C (77 °F). 6. Adjust pH with Citric Acid (50% aq. solution). Add dye and preservative.
