Procedure

Into a suitable vessel, add Deionized Water. Begin agitation. Heat to 170°F-175°F. In a separate vessel, prepare the oil phase by adding together NEOBEE® M-5 Cosmetic, Petrolatum, WECOBEE® S, Glyceryl Stearate, Cetyl Alcohol, Brij 789, and Dow Corning 200 Fluid. Heat to 170°F–175°F. Add oil phase to the water phase with agitation. Agitate for 30 minutes while holding the temperature between 170°F–175°F. Begin cooling. At 115°F, add phase 3. Cool with agitation to 80°F.

Check pH and viscosity.
